# University of Hull Undergraduate Excellence Scholarship Policy 2016-17 First year entrants in 2016

### 1. Background principles

This policy and procedural document aims to clarify the purpose, eligibility and conditions for undergraduate Excellence Scholarship award available to new entrants at the University of Hull (the University) in 2016/17.

The *University of Hull Excellence Scholarship* aims to provide financial support to entrants with high levels of academic achievement who come from backgrounds of low residual household income (RHI). This positions our Excellence Scholarship as part of our commitment to fair access in line with government direction.

A number of criteria make certain courses and individuals ineligible for these awards (see section 11 for further details).

The award of a *University of Hull Excellence Scholarship* nullifies any *University of Hull Studentship*, *University of Hull Merit Scholarship*, or *University of Hull Achievement Scholarship* award which would otherwise have been made.

Please note that for the purposes of Excellence Scholarship eligibility and conditions, the University does not distinguish between clearing and adjustment applications and pre-clearing applications.

### 2. Eligibility for an Award

To receive a *University of Hull Excellence Scholarship:* 

- Full and part time students must demonstrate a residual household income of less than £42,600 through assessment by Student Finance England. Section 11 gives further information.
- Students must have been assessed by the University as being required to pay tuition fees at the home student rate of £9,000 (part time pro rata). EU students who are required to pay fees at this £9,000 rate are eligible for consideration. International students (outside the EU) are ineligible.
- Students will have achieved AAB at A Level (or an equivalent qualification, as specified at www.hull.ac.uk/excellencescholarship). The University does not recognise General Studies A Level grades for the purpose of the Excellence Scholarship.

The following groups of students are not eligible to be considered for a *University of Hull Excellence Scholarship:* 

- Foundation Degree students.
- Students undertaking a Foundation Year. However students who have completed a
   University of Hull Foundation Year may be considered for an award if they subsequently
   enrol on an eligible undergraduate degree programme.
- Students who have previous experience of university study, including any level 4 course, or any part of a Foundation Degree or externally provided Foundation Year, regardless of level. This includes credits gained through Open University.
- Students from Scotland, Wales, Northern Ireland, Channel Islands or Isle of Man.
- Students who are fully or partially sponsored (see Appendix 1).

- Students entering courses funded by or supported through the NHS\*.
- Postgraduate students.
- International students (outside the EU).
- Students who have not have their Residual Household Income (RHI) assessed by Student Finance England.
- Students on programmes where admission is not administered exclusively by the University of Hull.

\*Social Work students are eligible to receive the University of Hull Excellence Scholarship while they are not in receipt of an NHS Bursary.

The accompanying tables at section 11 show full eligibility criteria for the *University of Hull Excellence Scholarship* and list those who would be ineligible.

# 3. Applications

*University of Hull Excellence Scholarships* will be automatically awarded to eligible entrants providing students and their sponsors consent to share their financial information through Student Finance England. Section 11 provides further information.

Successful students will be notified as they are identified.

### 4. Continuation of Award

2016/17 *University of Hull Excellence Scholarships* are awarded to high achieving students for three years of study, and as such successful progression is required for automatic continuation of the award.

- The Excellence Scholarship of any student continuing on to the next stage of their programme with deferred assessments or referred modules will be suspended pending a review of their progress, attendance, and any mitigating circumstances.
- Students will not receive any Scholarship award for periods of study (e.g. repeated years) for which awards have already been made.
- Excellence Scholarships are not payable during any period where the University tuition fee is reduced (e.g. a year abroad or a year's placement in industry).
- Transfer to an ordinary degree renders students ineligible for further payments.
- Student withdrawal from study ends all Excellence Scholarship awards (from the date of formal withdrawal).
- If an awardee intercalates they will remain eligible for the remainder of the award upon return to full time study, providing they continue to satisfy eligibility and progression criteria.
- Excellence Scholarships are payable for a maximum of 3 years (including where an awardee changes to another eligible programme of study).

### 5. Appeals

Any new entrant who believes (s)he has been unfairly excluded from an award (or part of it) has the right to appeal. Full details are included at Appendix 2.

#### 6. Number of awards

#### 7. Payment of Awards

The *University of Hull Excellence Scholarship* provides any combination of the following options to each Excellence Scholarship awardee in 2016/17, to the value of £2,100:

- Cash
- Accommodation discount
- Fee waiver

#### Please note:

- Fee waivers are logged on the individual student record at Student Finance England during the academic year.
- Accommodation discounts can be applied to University of Hull owned or managed accommodation only.

*University of Hull Excellence Scholarships* provide the potential for payments of cash:

- As a general principle no award will be paid prior to registration.
- Cash payments are made through Student Finance England, and staggered through the academic year directly into the awardee's bank account.
- Where a student has outstanding debts to the university any Scholarship payment will be released only when these debts have been paid. Scholarship payments can be used to reduce any debt to the university at the awardee's request.

Please note an Excellence Scholarship award may be considered as income received for the purposes of any application to the University of Hull's Hardship Fund.

### 8. Publicity

The University will ensure that the Excellence Scholarship scheme outlined above is publicised as widely as possible to potential applicants to the University. This will include via the University of Hull website (<a href="www.hull.ac.uk">www.hull.ac.uk</a>) and printed promotional materials. Publicity will include full conditions/eligibility criteria relating to the Excellence Scholarship where possible, or links to these, and be updated by mid-September each year for the following September entry.

Relevant schemes may also be promoted by individual academic departments in their promotional literature and websites whilst ensuring content is appropriately referenced to the University website (<a href="www.hull.ac.uk">www.hull.ac.uk</a>) to ensure current information is always available.

All Access Agreements are published on the OFFA website (www.offa.org.uk).

# 9. Responsibilities

The University's Pro-Vice Chancellor (Engagement) has overall responsibility within the University for the Implementation of this policy. The practical implementation of the policy is the responsibility of the Director of Student Recruitment, assisted by members of the Directorate.

Management of the various elements of the awarded Excellence Scholarships, including the payment of any cash, resides with appropriate departments across the University.

# 10. Monitoring and Review of this Policy

This document refers explicitly to arrangements for Excellence Scholarships awarded to those entering the University in 2016/17. The policy will be formally reviewed for 2017/18 entry.

#### Appendix 1: Sponsorship

Full or part sponsorship reduces fees payable by the individual student entering full honours degrees to less than £9,000 per annum and results in students becoming ineligible for the Excellence Scholarship.

The following examples illustrate this situation:

- **Corporate sponsorship** of an individual from an employing organisation, managed via a system of purchase order and invoice.
- Students entering ordinarily resident in Wales, Scotland and Northern Ireland who are required to personally pay reduced fees, the balance being covered by government/assembly funds (Government sponsorship).
- Where academic departments charge discounted fees (University sponsorship).

The following groups are excluded from the above definition of sponsorship:

- Students entering from a background of care who are assisted by their local council in line with the Children and Young Persons Act 2008 which requires local authorities to give a minimum bursary of £2,000 to care leavers starting a recognised higher education course in line with OFFA guidance. (Corporate parenting)
- Students entering from a background of care who are assisted with fees by local councils. (Corporate parenting)
- Self-financing students are also excluded from the definition of sponsorship.

# Appendix 2: Guidance on University of Hull Appeals Procedure relating to Excellence Scholarships

# **Appeals Procedure - Guidance**

# **University of Hull Excellence Scholarship**

If you believe you were entitled to a *University of Hull Excellence Scholarship* but are unhappy with the assessment or amount awarded, you may have the right to appeal.

### Before you appeal

Before appealing there are a few steps you can take:

- 1 E-mail hefunding@hull.ac.uk to address any initial queries.
- 2 Check you fulfil the eligibility criteria for an award (see section 11 of the University of Hull Undergraduate Excellence Scholarship Policy 2016-17).

#### How do you know if you can appeal?

You can appeal when:

- You think you meet all of the Excellence Scholarship eligibility criteria.
- You have provided evidence of your residual household income.
- You have provided evidence of your previous qualifications.
- All consents for SFE to share your information with the university were provided.

# When you can't appeal

You can't appeal when:

- You don't meet the necessary eligibility criteria.
- You have not given your consent to SFE to share your information with the University.
- You have not provided evidence of your residual household income.
- You have appealed previously.

#### Who can appeal?

Appeals must be made by the student concerned, who is registered at the University of Hull. Someone else cannot appeal on your behalf.

#### **Deadline for appeals**

Appeals must be made during the academic year concerned. Appeals should be made no later than 8 weeks prior to the end of the academic year.

# How to appeal

Appeals should be made in writing to the Access, Funding and Support Officer.

Appeals must include your name, contact details, student number and course. You should say in your appeal why you believe your assessment is incorrect.

#### What happens next?

Your eligibility will be checked. All completed appeals are reviewed within 2 - 4 weeks. You will be notified of the outcome of your appeal via an email to your University email account.

#### The possible outcomes are:

You are not eligible for the *University of Hull Excellence Scholarship* and the decision will be explained to you.

- If there is missing information or evidence which is required in order to assess your claim you will be asked to withdraw your appeal and ensure that the required information is supplied.
- 3 You are deemed eligible for the *University of Hull Excellence Scholarship*.
- 4 You may be directed to others sources of support.

If you are unhappy with the appeal decision the case will be reviewed by the Director of Student Recruitment, whose decision is final.

# Withdrawing your appeal

You can withdraw your appeal at any time by writing to the Access, Funding & Support Office.
