Our curriculum is driven by both our research and practice expertise, from commercial law, environmental law and criminal justice to mediation, family law, human rights law, international law and security.


At our Law School, you'll not only gain legal knowledge, but also learn how to apply it using 21st century skills and practices to solve 21st century problems.

Benefits of studying Law in the UK

For Canadian students, one of the key advantages of studying Law in the UK is the speed and cost-effectiveness of completing the degree.

In the UK, Canadian students can study our three-year undergraduate Law degrees directly from high school, and students who have already completed an undergraduate degree can apply for our fast-track two-year LLB Law (Senior Status) programme. This is much quicker compared to the seven years typically required in Canada (four years of undergraduate study plus three years of law school).

Studying Law in the UK exposes Canadian students to Common Law, which is shared between the UK and Canada. This exposure provides invaluable insight into different legal interpretations, giving graduates a broader perspective and a competitive edge when returning to Canada.

Here at Hull, you don't just study Law – you get hands-on experience too. You'll get the chance to provide legal advice to real clients at our Legal Advice Centre and our recently enhanced Mediation Centre. You can even take part in internships with local law firms and government, work with professional family mediators on real cases, and mini pupillages with the Wilberforce Chambers in Hull.







Get hands-on experience at our Legal Advice Centre

Our on-campus Legal Advice Centre provides final year LLB Law students with the opportunity to gain valuable experience working on real mediation disputes. Under the supervision of staff, Law students put their learning into practice to provide free, confidential and independent advice to the local community, while gaining valuable, practical experience in the legal profession.



Learn the legal ropes in our mock courtrooms

Our mock court allows you to bring the courtroom to life right here on campus. We have mock law courts for family and civil matters, as well as a criminal courtroom. Our mock law court features a dock for 'the accused', witness box, jury area, public gallery, and Judge's chamber, so you can experience exactly what it's like to take part in formal legal proceedings.



Spend a year in Westminster with an MP or Peer

We're very proud to offer our LLB Law with Legislative Studies students a year spent on placement in Westminster, working for a Member of Parliament or a Peer. You'll have access to our exclusive seminar series which features presentations by senior Parliamentary officials including Black Rod, the Speaker, the Serieant-at-Arms, and the Clerk of the House of Commons. There are so many of University of Hull graduates now working in Westminster that they've affectionately become known as 'the Hull Mafia'.



Undertake an internship or mini pupillage

Get real-world experience with an internship with local law firms and government, mini pupillages with the Wilberforce Chambers in Hull, or take part in rewarding volunteering projects working with real legal issues. Our Centre for Professional Success is a one-stopshop for opportunities and support, including around internships and minipupillages.

Students on our LLB Law programme or a joint honours LLB Law programme with Politics, Business Management, or Criminology, have the option to add a year abroad at one of our partner universities in Germany, France, the Netherlands, Italy and Spain. This is taken as an additional year after the second year. This is a fantastic opportunity to gain skills that employers take notice of: curiosity, adaptability, sociability, and intercultural awareness.



Join our Student Law

The University of Hull Law Society is a vibrant and inclusive community. offering opportunities to enrich your legal education and connect with fellow students and legal professionals. Students take part in competitive mooting, client interviewing as well as mediation - all with the help of local practitioners and the judiciary. The Society also hosts social events throughout the year, from formal balls and themed parties to fun meet-ups and quest speaker events.

Careers and employability

We've been teaching Law at Hull since the University was founded in 1927, and our graduates form a wide network around the world. Our graduates have gone on to careers as solicitors, barristers and legal executives, as well as areas outside of the legal profession including politics, teaching, the civil service, financial services, and HM Armed Forces.

Our LLB programmes cover the foundations of legal knowledge, which are essential for going into legal practice. We have designed our programmes with your future in mind, so you can develop the skills and knowledge that is highly sought after by a range of employers inside and outside the legal field.

We offer the opportunity for our students to meet leading law firms from across the UK at our Annual Law Convention. We invite law firms covering all sectors – from corporate and commercial to legal services teams at both local authority and Government level – giving students a real flavour of the variety of careers available to them.

Some of our Canadian graduates choose to stay in the UK after graduating, and we are well connected with local and national employers to help graduates in their careers. Many graduates also choose to return to Canada to practice Law.

Our Centre for Professional Success is a one-stop-shop for career advice, opportunities and support, including around internships and mini-pupillages. The University of Hull also offers a careers service, which is available throughout your studies and after graduation. Their team of experts are trained to connect you to find opportunities that will suit your career aspirations and give you a head start in today's competitive jobs market.



Using your Law degree to qualify in Canada

Law graduates can apply to practice in Canada by completing the National Committee on Accreditation (NCA) process, which assesses the equivalency of Law degrees outside of Canada.

Completing a degree in the UK, and getting NCA certified, can be faster and more flexible than studying for a Law degree in Canada. Find out more information at: https://nca.legal/

How to obtain the NCA Certificate of Qualification

There are three ways you can get your NCA Certificate of Qualification:

- Complete additional courses at a Canadian Law School check with the NCA what courses you need to do and if the Law School you wish to do the courses with has the appropriate accreditations
- Use online or self-study options ensure that these meet the NCA's accreditation requirements
- 3. Combine both the above approaches

The NCA assesses each application individually, reviewing both your educational background and professional experience. The NCA will specify which subjects or legal training you need to match the Canadian law school curriculum. Once you meet all requirements, you can apply for a Certificate of Qualification, which qualifies you to practice at the Common Law Bar in most provinces. Please note Quebec may have a different qualification process.



How our undergraduate Law degrees prepare you

Our Law degrees cover the seven foundations of legal knowledge required for a qualifying Law degree in Canada, and importantly we cover the three core subjects in private law: Tort, Contract, and Property Law. This provides a solid foundation toward NCA qualification.

The six NCA exams required for qualification in Canada are:

- Foundations of Canadian Law
- Canadian Criminal Law
- Canadian Constitutional Law
- Canadian Administrative Law
- Canadian Professional Responsibility
- Canadian Legal Research and Writing

To help build your skills and a solid foundation for the Professional Responsibility and Legal Research and Writing exams, we recommend students choose our Law Clinic module, and select a professionally focused project in your final-year Capstone project.

In addition, the NCA requires the following core subjects for accreditation, which our Law degrees cover. The content is so similar between England and Canada that, provided you achieve at least 45% in each, you will not need to repeat them in Canada. These subjects are:

- Tort Law
- Contract Law
- Property Law

NCA exams

You will need a 2:2 or higher in your Law degree (50% average, equivalent to a 60% average in Canada), with no marks below 45% in each module to be eligible to take the NCA exams. The NCA exams you are required to sit vary based on your Law degree and whether you have studied at university previously:

- Two-year LLB Law (fast track), three-year LLB Law (with less than two-year previous university study), or LLB Law joint honours degrees you'll likely need to take seven exams (five mandatory exams and two additional exams determined by the NCA) and the module 'Canadian Legal Research and Writing'.
- LLB Law (with two years previous university experience) you'll likely need to take the five mandatory exams and the module 'Canadian Legal Research and Writing'.

All the lecturers are very motivated for the success of their students and encourage questions and active participation in the classes. The University of Hull, in its own right, is a well-established University, having been established in 1927. Entry requirements

Undergraduate

- Alberta, British Columbia, Manitoba: 60% average across a combination of five Grade 12 courses
- New Brunswick, Newfoundland and Labrador, Northwest Territories, Nova Scotia, Nunavut, Prince Edward Island, Saskatchewan, Yukon: 65% average across a combination of five Grade 12 courses
- Ontario: 65% average across a combination of six Grade 12 U or M courses
- Quebec: Diplôme d'Études Collégiales with a 65% overall average

For our two-year LLB Law (Senior Status) programme, applicants need a postgraduate degree equivalent to a UK 2:2 (these equivalents are listed below).

How to apply

Undergraduate

Students should apply through the University and Colleges Admissions Service (UCAS). This is the route to applying for all undergraduate programmes in the UK. We do not require any admissions tests, such as the Law School Admission Test (LSAT).

It is very easy to apply – applicants submit one online application for up to five universities and pay one fee (£28.50 for 2025 entry). Visit www.ucas.com to start your application.
