- > Activities and facilities considered to be wholly or partly under the Universities control
- Employees, students, researchers, visitors (including members of the public and contractors) and others involved with the activities and facilities including those travelling in the UK or overseas

STANDARDS

□ 1-S1	Strategic leadership is provided by ULT for health and safety and decisions
□ 1-S2	Health and safety planning is integrated into the University's mainstream planning cycles

□ 1-S3	Adequate resources are provided to meet the University's health, safety and welfare obligations
□ 1-S4	Competent specialist advice is provided by the Health and Safety Service to support and enable informed decisions
□ 1-S5	All those with health and safety roles, whether decision making or practical applications, are equipped with the relevant knowledge, competence and capacity
□ 1-S6	An effective Health and Safety Management System and associated arrangements are implemented and continually, reviewed and improved to assist in reducing and controlling risk and reducing and preventing accidents and ill health arising from our work activities
