

#### International Office Postgraduate Taught Scholarships 2019: Terms and Conditions

The University of Hull International Office is offering 50 tuition fee scholarships worth £5,000 each to full-time Postgraduate Taught students from the following countries:

BangladeshIndiaNigeriaVietnam

• Egypt • Indonesia • Pakistan

• Ghana • Kenya • Thailand

30 scholarships available for applicants who apply before 30 April 2019 (Round One) and a further 20 scholarships are available for applicants who apply between 30 April 2019 and 28 June 2019 (Round Two). The duration of the scholarship is for one year and will be awarded as a tuition fee discount. Applicants must be available to commence their studies by the start of the University's academic year in September 2019.

The £5,000 award is calculated as follows:

International Studentship Scheme Postgraduate Discount	£2,500
World Bank Discount (if applicable)*	£1,000
Merit-based Scholarship*	£1,500
Total	£5,000

<sup>\*</sup>Applicants from Thailand are not eligible for the World Bank Discount, therefore the merit-based scholarship will be increased to £2,500 for these students.

Unsuccessful scholarship applicants will continue to be eligible for the studentship and (if applicable) the World Bank Discount.

### How to apply:

Applicants must apply for the scholarship using the online application form. The closing dates are:

- Round One 12:00 BST on 30 April 2019
- Round Two 12:00 BST on 28 June 2019

# **Selection Process:**

- The International Office will appoint a committee to approve the award of the scholarships. The committee will be made up of representatives from the International Office and academic Faculties.
- The committee will endeavour to meet within 10 days of the application deadlines.
- Successful applicants will be informed by email within 48 hours of the committee's decision.
- Applicants will be selected on the strength of their academic achievements and the quality of the answers provided in the scholarship application form.

# International Office Postgraduate Taught Scholarships 2019: Terms and Conditions

#### **Eligibility:**

- Priority will be given to those applicants who have already met the terms of their offer by the closing dates.
- Applicants must have achieved a minimum 2.1 degree classification at bachelors level or equivalent. Priority will be given to first class degree holders or equivalent.
- Applicants must also meet the University's standard language requirements for their chosen course of study.
- The scholarship is open to both new applicants and existing offer holders for September 2019 entry.
- The scholarship is available to direct (non-partner) applicants only and applicants must be selffunded.
- The scholarship is not available to applicants who have studied at university level or worked for one (academic) year or more in an upper middle or high income country as defined by the World Bank.
- Scholarship applicants must be nationals of and normally resident in any of the eligible countries (see above) and be available to start their academic studies at the University of Hull in September 2019. Applicants wishing to defer their entry will not be considered for an award.
- Applications will be considered for any area of study. The University will seek to allocate the 50 scholarships equally across all four Faculties (depending on the quality of the applications received).
- Successful applicants must be able to demonstrate to the University that they have the necessary living expenses as required under UKVI regulations prior to the University issuing a Tier 4 certificate of sponsorship. If applicants are unable to do this before 1 August 2019 then the offer of the scholarship may be withdrawn.
- The scholarship is deducted from tuition fees only and does not cover living expenses.
- Scholarships are not transferable between Faculties and successful applicants may not hold more than one University scholarship award.
- The scholarship cannot be used in lieu of the £2000 tuition fee deposit. Successful applicants in Round One must pay their £2000 deposit within 30 days of receiving confirmation of their award from the University or the offer of an award may be withdrawn. Successful applicants in Round Two must pay their £2000 deposit within 10 days of receiving confirmation of their award from the University or the offer of an award may be withdrawn.
- Applicants who are not successful in Round One will not be re-considered in Round Two and may not re-apply.
