Response

1. As of 1st December 2023 (the in-year census date for 23/24) please see figures below. Please note they do not represent the full academic year, as that hasn't been completed yet. We have limited it to students who are on campus, seeing as the rest of the questions relate to accommodation (i.e. excluding those who are distance-taught, doing online courses, or doing apprenticeships).

- Total: 12,725 (headcount, rounded to nearest 5)
- 12,010 full-time/720 part-time (and therefore assumed less likely to require university accommodation)
- Domestic/international based on domicile: 8,985 mainland UK/3,740 international

2. 1,462 at Westfield Court, 562 The Courtyard and 288 Taylor Court – Total 2,312

3. 17 Accessible Rooms at Westfield Court and 6 at The Courtyard – Total 23

5. The University would not be involved in making such an assessment. Most typically, adults with physical disabilities, where adaptations to accommodation are required, are under the care of Adult Social Care within their home Local Authority. It's Adult Social Care who assess need and make recommendations for adapted living where it is required.

Some individuals do have ongoing support and input from Occupational Therapy, and Physiotherapy (for example) in addition to Social Care, where conditions are ongoing or degenerative. It's often a team approach and a team decision around supportive measures and resources, as well as in full consideration of the disabled person's preferences. We would certainly be part of a wider team, but in no way assess need or commission other providers. Where this has happened before it has been a joint approach with Disability & Inclusion, Accommodation Services, Accommodation Operations, University Fire Safety Officer, the individual and their specialists and where necessary Humberside Fire & Rescue.

7. Most recently this was managed by Student Support Services and Estates with Student Support taking the lead. Future works would be managed similarly, case by case, involving H&S, Accommodation Hub, Disability Services, Estates, and / or accommodation management teams as necessary.

8. Section 1 of the Freedom of Information Act 2000 (FOIA) places two duties on public authorities. Unless exemptions apply, the first duty at Section 1(1)(a) is to confirm or deny whether the information specified in a request is held. The second duty at Section 1(1)(b) is to disclose information that has been confirmed as being held. Where exemptions are relied upon Section 17 of FOIA requires that we provide the applicant with a notice which: a) states that fact b) specifies the exemption(s) in question and c) states (if that would not otherwise be apparent) why the exemption applies.

It has been determined that this information is exempt on the basis that s21 of the Act applies – Information Reasonably Accessible by Other Means.
