2. Who performs this teaching? Are they e.g. a frenulotomist, midwife etc.? What qualifications do they hold in relation to infant feeding and tongue-tie?

3. Is this a signed-off skill?

<u>Response</u>

1. Is the topic of tongue-tie (ankyloglossia) included in the curriculum for this course? – The concept of tongue-tie might be raised by students when discussing factors that may affect the neonate's ability to obtain sufficient milk when discussing effective attachment.
